Personal information and interactive features.

Certain features of the First United Methodist Church may require you to register personal information and create a username and password. You are responsible for maintaining the confidentiality of your account username and password and are responsible for all uses of your account, whether or not actually or expressly authorized by you. The First United Methodist Church grants you a non-exclusive, non-transferrable license to create an account for and use the First United Methodist Church in accordance with the Terms of Use.
